Question 1

The impact of the COVID-19 on Africa

The economy of many African countries may enter a recession at least in the first half of the year 2020, when adding the direct and indirect effects of the crisis (e.g. supply and demand shocks, commodity slump, fall in tourism arrivals, etc.) However, as the pandemic progresses slowly on the African continent, studies by international organizations addressed less the economic impact on individual African countries. Africa, because of its openness to international trade and migration, is not immune to the harmful effects of COVID-19 on its economy. Due to the difficulty of quantifying the real impact as a result of the uncertainty, the rapidly evolving nature of the pandemic, and scarcity of the data, there is need for focused research in Africa. The lessons learnt from such studies will give enlightenment more on how the continent has been affected to date given that the continent is still in critical phase of the implementation of containment measures.
